DAY-AT-A-GLANCE

February 11, 2026, was defined by a high-stakes convergence of constitutional crises, fiscal deadlines, and a massive moral reckoning regarding the Jeffrey Epstein files. Attorney General Pam Bondi faced a combative House Judiciary Committee hearing where she was accused of "botching" the release of 3 million pages of Epstein-related documents by outing victims while redacting the names of high-profile perpetrators. Simultaneously, the Department of Commerce Secretary, Howard Lutnick, faced calls for resignation after unsealed files contradicted his previous claims of cutting contact with Epstein after 2005. This fallout shadowed a day where the U.S. House passed the **SAVE America Act**, a controversial bill federalizing election standards by requiring proof of citizenship for registration and photo ID for voting.

The legislative agenda was further complicated by an impending funding lapse for the Department of Homeland Security (DHS) set for Friday, February 13. While Republicans and Democrats remain at an impasse over ICE en-

forcement protocols—specifically regarding the use of masks, body cameras, and warrants—the House successfully moved a rule to block the repeal of President Trump’s tariff-related emergency declarations through July. Adding to the tension, Senators Mark Kelly and Elissa Slotkin held a press conference following a D.C. grand jury’s refusal to indict them for their "military orders" video, which they characterized as a historic failure of the administration's attempts to weaponize the DOJ against the legislative branch.

MAJOR DEVELOPMENTS

The Epstein Files and DOJ Oversight

- Attorney General Pam Bondi testified that the DOJ released 3 million pages of Epstein files but faced bipartisan criticism for redaction errors that exposed victim identities while shielding alleged co-conspirators. ([Source](#), [Source](#))
- Representatives Ro Khanna and Thomas Massie reported finding six "powerful men" hidden in the files without legal justification, including billionaire Leslie Wexner, whom the FBI labeled a co-conspirator. ([Source](#), [Source](#))
- Commerce Secretary Howard Lutnick confirmed a 2012 visit to Epstein's island with his family, despite earlier claims of ending contact in 2005, leading to widespread calls for his resignation. ([Source](#), [Source](#))
- Senator Schumer and Representative Leger Fernandez introduced "**Virginia’s Law**," named for Virginia Giuffre, to eliminate statutes of limitations for civil claims related to adult sex trafficking. ([Source](#), [Source](#))

DHS Funding Impasse and ICE Operations

- Funding for the Coast Guard, TSA, and FEMA is set to expire at midnight Friday as Senate Democrats demand ICE reforms (body cameras, judicial warrants, and unmasking agents) as a condition for support. ([Source](#), [Source](#), [Source](#))
- Acting ICE Director Todd Lyons defended the use of masks by agents due to an 8,000% increase in death threats but refused to provide data on officer disciplinary actions following the fatal shootings of U.S. citizens in Minnesota. ([Source](#), [Source](#))
- Republican leaders argue that ICE is already funded through 2029 via reconciliation, meaning a shutdown would only hurt non-immigration agencies like the Secret Service and FEMA. ([Source](#))

Election Integrity and the SAVE America Act

- The House passed **S. 1383 (The SAVE America Act)** by a 223-206 vote, mandating proof of citizenship for federal registration and a government-issued photo ID to vote. ([Source](#), [Source](#))
- Democrats argued the bill constitutes a "modern-day poll tax" and "Jim Crow 2.0," claiming it will disenfranchise 21 million citizens who lack easy access to birth certificates or passports. ([Source](#), [Source](#))
- A provision in the act requires states to share full voter roll data with the DHS, sparking privacy and federalism concerns. ([Source](#), [Source](#))

Constitutional Friction: The Kelly/Slotkin Indictment Failure

- A federal grand jury declined to indict six Democratic lawmakers, including Senators Kelly and Slotkin, over a video advising military members to refuse "unlawful orders." ([Source](#), [Source](#))
- Kelly and Slotkin characterized the attempted indictment as an "authoritarian playbook" move by the administration to silence dissent via the Speech or Debate Clause. ([Source](#))

DEEP DIVE: TRENDS AND THEMES

Weaponization vs. Accountability: A recurring theme is the mirrored use of the term "weaponization." Republicans cite "Arctic Frost" (the Jack Smith investigation into Republican lawmakers' phone records) as the ultimate weaponization of government ([Source](#)). Conversely, Democrats point to the attempted indictments of Senators Kelly and Slotkin and the targeting of New York AG Letitia James as proof of a "vendetta factory" operating within the Bondi-led DOJ ([Source](#), [Source](#)).

Federalism under Strain: The administration is increasingly moving to "nationalize" functions historically left to states. This is evident in the **SAVE America Act's** override of state election procedures ([Source](#)) and the DOJ's "shakedown" of Minnesota, where federal agents remained in cities pending the turnover of state voter rolls ([Source](#), [Source](#)).

The "Epstein Class" Polarization: The Epstein files have transitioned from a general scandal to a specific political bludgeon. Democrats are using the unsealed documents to pressure the administration to fire Cabinet members (Lutnick) and to highlight alleged

ties between Trump and Epstein ([Source](#), [Source](#)). Republicans, led by Bondi, are refocusing the narrative on Democratic figures like Hakeem Jeffries and Bill Clinton mentioned in the same files ([Source](#), [Source](#)).

HYPOTHESES AND FUTURE LEGISLATIVE OUTLOOK

Impending DHS Shutdown: Given Speaker Johnson's refusal to concede on ICE reforms and Leader Thune's preference for a stopgap ([Source](#), [Source](#)), a partial shutdown of the Secret Service, Coast Guard, and TSA appears highly likely by Saturday morning. The political fallout will depend on the duration and the impact on air travel during the spring season.

Judicial Review of Executive Authority: The House's decision to toll the clock on tariff challenges until July ([Source](#), [Source](#)) suggests the GOP is betting on a favorable Supreme Court ruling regarding the International Emergency Economic Powers Act (IEEPA). If the Court rules against the President, a wave of legislative challenges to current tariffs will immediately hit the floor.

Expansion of "Virginia's Law": The moral weight of the survivors present at the Capitol ([Source](#)) suggests that Schumer's bill to remove statutes of limitations may gain enough bipartisan traction to pass, especially as members of both parties seek to distance themselves from the "Epstein Class."

The day was dominated by debates over election federalization, trade authority, and child safety technology.

This inaugural report is based on deep analysis of CSPAN, CSPAN2 and CSPAN3 coverage in collaboration with the Internet Archive's TV News Archive. It is currently limited to the Congressional business covered on those three CSPAN channels and thus may not include all major Congressional business, may include activity from previous days that aired on a later date, and/or may include other major federal, state and local governmental business. We will continue to refine this report to incorporate a growing array of Congressional information sources.
